

Rule 11. Unit of appointment :—For purpose of appointment by transfer, discharge and reappointment and appointment as full member, transfer and posting, each of the Multizone-I and Multizone-II shall be a separate unit of appointment* as indicated in the table below :

Category/ Class	Post	Unit of appointment
Category 5	Statistical Officer	Multizone-I comprising Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur, Prakasam and Nellore districts, Multizone-II comprising Cuddapah, Kurnool, Anantapur, Chittoor, Adilabad, Karimnagar, Warangal, Khammam, Nalgonda, Mahabubnagar, Medak, Nizamabad, Ranga Reddy and Hyderabad districts.

Provided that the posts of Statistical Officers in the Office of the Directorate of Economics and Statistics, the Secretariat, Offices of Heads of Departments and other Offices to which the Andhra Pradesh Public Employment (Organisation of Local Cadres and Regulation of Direct Recruitment) Order, 1975 is not applicable, shall be filled by drawing persons holding the said posts from each of the Multizonal Cadres in the ratio of the basic cadre strength of each of the Multizonal units ;

Provided further that the posts of Statistical Officers in the State Apex Corporations or other Institutions which have jurisdiction over the entire State, shall be filled by deputation of persons holding the said posts, in each of the multizonal units in the ratio of the basic cadre strength of the posts in each of the said multizonal units ;

Provided also that the posts of Statistical Officers in the Offices, which have been notified as Special Offices or Establishments under the Andhra Pradesh Public Employment (Organisation of Local Cares and Regulation of Direct Recruitment) Order, 1975 shall be filled up by deputation of persons from the multizonal units in the areas over which such a Special Office or Establishment has jurisdiction ;

Provided also that the posts of Statistical Officers in the branch offices of Corporations, or Institutions which have jurisdiction within the area comprising each of the multizonal units, shall be filled by deputation of persons from the respective multizonal units.

Provided that the persons who are regularly appointed as Deputy Statistical Officers or Superintendents as on the date of issue of these rules, and have not passed the Accounts Test for Executive Officers are also eligible for appointment by transfer to Category 5 (Statistical Officer). They should however pass the Accounts Test for Executive Officers within the period of probation.

Note :—This proviso shall be in force for a period of two years from the date of commencement of these rules.

31. The Andhra Pradesh Economic and Statistical Subordinate Service Rules

[G.O.Ms.No. 42, F & Plg., Dept., Dt. 11-6-1991]

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the Notification II issued in G.O.Ms.No. 216, Plg. & Dev. (Plg. IV) Department, dated the 2nd March, 1959 as amended from time to time, the Governor of Andhra Pradesh hereby makes the following Rules for the Andhra Pradesh Economic and Statistical Subordinate Service.

Rule 1. Short title :—These rules may be called the Andhra Pradesh Economic and Statistical Subordinate Service Rules, 1991.

Rule 2. Constitution :—The Subordinate service shall consist of the following categories of posts in the Directorate Economics and Statistics.

- Category 1 : Deputy Statistical Officer.
 Category 2 : [Assistant Statistical Officer] (including posts formerly designated as Jr. Investigators, Progress Assts. and Taluk Statistical Assistants).
 Category 3 : Punch Operator.
 Category 4 : Senior Draughtsman
 Category 5 : Artist
 Category 6 : Draughtsman
 Category 7 : Tracer

Rule 3. Method of appointment and appointing authority :—Subject to the other provisions to these rules, the method of appointment and appointing authority for the several categories of posts shall be as follows :

Provided that promotion upto the posts of Deputy Statistical Officers in Category-1 shall be made from the Assistant Statistical Officers formerly appointed to the categories of Progress Assistants, Taluk Statistical Assistants and Junior Investigators in the order of rotation specified below in every cycle of fifteen vacancies till all the candidates regularly appointed upto 30-1-1986 in those categories are exhausted.

1. Assistant Statistical Officer (formerly appointed as Progress Assistant)
2. Assistant Statistical Officer (formerly appointed as Taluk Statistical Assistant)
3. Assistant Statistical Officer (formerly appointed as Progress Assistant)
4. Assistant Statistical Officer (formerly appointed as Junior Investigator)
5. Assistant Statistical Officer (formerly appointed as Progress Assistant)
6. Assistant Statistical Officer (formerly appointed as Progress Assistant)
7. Assistant Statistical Officer (formerly appointed as Taluk Statistical Assistant).
8. Assistant Statistical Officer (formerly appointed as Progress Assistant)
9. Assistant Statistical Officer (formerly appointed as Junior Investigator)
10. Assistant Statistical Officer (formerly appointed as Progress Assistant)

Provided further that promotion to the posts of Assistant Statistical Officer in Category-2 shall be made against one vacancy in every unit of ten vacancies until all the existing incumbents in the category of Punch Operator get exhausted.

Note :—The provision relating to promotion to the posts in Categories 4, 5 and 6 is applicable only to the candidates presently holding the respective posts in the Directorate of Economics and Statistics and not to the persons drawn on tenure basis from the Andhra Pradesh Roads and Buildings Engineering Subordinate Service.

[Rule 4. Reservation of appointment :— In the matter of direct recruitment to Category 2 (Statistician) Rules 22 and 22-A of the Andhra Pradesh State and Subordinate Services Rules, 1996, shall apply.]

Rule 5. Qualifications :—No person shall be eligible for appointment to the categories specified in Column (1) of the Annexure to these rules by the method specified in Column (2) unless he possesses the qualifications specified in the corresponding entry in Column (3) thereof.

Rule 6. Age :—No person shall be eligible for appointment by direct recruitment if he has completed twenty eight years of age on the first day of July of the year in which the selection is made.

Rule 7. Minimum service :—No member of the service shall be eligible for promotion to the next higher Category of post unless he has put in three years of service after the date of commencement of his probation, in the category from which promotion is made.

Rule 8. Probation :—Every person appointed to any post in the service shall, from the date on which he commences probation be on probation, for a total period of one year on duty within a continuous period of two years, if appointed by promotion or by transfer and for a total period of two years on duty within a continuous period of three years, if appointed by direct recruitment.

Rule 9. Unit of appointment :—For purposes of recruitment, appointment, discharge for want of vacancy, seniority, promotion, posting and transfer and appointment as full member, the unit of appointment shall be as specified in the table below :—

Provided that the posts of Deputy Statistical Officers and Statisticians in the Office of the Directorate of Economics and Statistics, the Secretariat, Offices of Heads of

Departments and other Offices to which the Andhra Pradesh Public Employment (Organisation of Local Cadres and Regulation of Direct Recruitment) Order, 1975 is not applicable, shall be filled by drawing person holding the said posts from each of the zonal cadres in the ratio of the basic cadre strength of each of the zonal units ;

Provided further that the posts of Deputy Statistical Officers and Statisticians in the State Apex Corporations or other Institutions which have jurisdictions over the entire State, shall be filled by the deputation of persons holding the said posts, in each of the zonal units in the ratio of the basic cadre strength of the posts in each of the said zonal units ;

Provided also that the posts of Deputy Statistical Officers and Statisticians in the Offices, which have been notified as Social Offices under the Andhra Pradesh Public Employment (Organisation of Local Cadres and Regulation of Direct Recruitment) Order, 1975, shall be filled up by deputation of persons from the zonal units in the areas over which such a special office or establishment has jurisdiction ;

Provided also that the posts of Deputy Statistical Officers and Statisticians in the Branch Offices of Corporations or Institutions which have jurisdiction within the area comprising each of the zonal units, shall be filled by deputation of persons from the respective zonal units.

Rule 10. Transfers and postings :—The Director, Directorate of Economics and Statistics shall be the authority competent to affect transfers and postings of various categories in the service :

Provided that in the case of Categories 1 and 2 the Chief Planning Officers of the districts concerned, shall also be competent to give postings and transfers within their districts.

32. The Andhra Pradesh Educational Service Rules

[G.O. Ms. No. 505, Education (Services-I), dt. 16-11-1998]

In exercise of the powers conferred by sub-section (1) and (2) of Section 78 read with Section 99 of the A.P. Education Act, 1982 (Act 1 of 1982), and in supersession of the Rules issued in G.O.Ms.No. 259, GA (Rules) Dept., Dt. 9-2-1962 and adhoc rules issued in so far as they relate to the posts included in this service, the Governor of Andhra Pradesh hereby makes the following special rules for the Andhra Pradesh Educational Service.

The rules hereby made shall be deemed to have come into force with effect from the 30th December, 1996.

1. **Short Title** :—These rules may be called the Andhra Pradesh Educational Service Rules.

2. **Constitution** :—The service shall consist of the following classes and categories of posts.

CLASS-I

CATEGORY-1: Director.

CATEGORY-1(a): Addl. Director.

CATEGORY-2 : Joint Director, Regional Joint Director.

CATEGORY-3: Principal, Institute of Advanced Studies in Education. (I.A.S.E.).

CLASS-II

CATEGORY-1: District Educational Officer, Deputy Director.

CATEGORY-2: Principal, College of Teacher Education (CTE).

CATEGORY-3: Principal, District Institute of Education and Training (DIET).

CATEGORY-4: Professor, I.A.S.E./State Council of Educational Research and Training (S.C.E.R.T.).

CATEGORY-5: Principal, Govt. College of Physical Education (G.C.P.E.).

CATEGORY-6: Deputy Director (Oriental Studies).

CATEGORY-7: Special Officer (Text books).

CATEGORY-1: Deputy Educational Officer, Gazetted Headmaster/Headmistress-Grade-I
