ORDER:-

In the G.O.Rt.No: 4433, G.A.Department, dated 04-12-1986, the OMC (SPF & Services) had been entrusted with the work of Comprehensive examination and updating of the existing service rules. The OMC accordingly took up the examination of the Rules relating to the Non-gazetted categories in the Employment and Training (Trg.Wing) Department. The draft rules prepared by the OMC have been examined in consultation with the Commissioner, Employment and Training and the APPSC.

2. The following Notification will be published in the Andhra Pradesh Gazette.

NOTIFICATION

In the exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling the Governor of Andhra Pradesh hereby makes the following special rules for the Andhra Pradesh Craftsmen Training Subordinate Service, and they will come into force with immediate effect.

RULES

1. Short Title:

These rules may be called "The Andhra Pradesh Craftsmen Training Subordinate Service Rules, 1995".

2. Constitution:

The service shall consist of the following classes and categories of the posts in the Andhra Pradesh Craftsmen Training Subordinate Service; namely:-

CLASS - A:

Category (1) Training Officer, formerly designated as Group Instructor, Junior Assistant Apprenticeship Adviser, Lecturer in Related Instructions Class Centres, Senior Technical Assistant in the Directorate and Millwright Foreman.

Category (2) Deputy Training Officer, formerly designated as Senior Allied Trade Instructor, Maintenance Mechanic, Senior Craft Instructor, Instructor in District Level Training Centres, Maths-cum-Drawing Instructor, Drawing-cum-Maths Instructor and Technical Assistant in the Directorate.

Category (3) Assistant Training Officer, formerly designated as Junior Craft Instructor, Motor Driving Instructor, Drawing Instructor, Maths Instructor (which is also called as Workshop Calculation and Science Instructor), Junior Allied Trade Instructor, Stenography Instructor, Language Instructor, Social Studies Instructor and Millwright Instructor.

Category (4) Technical Assistant, formerly designated as Maistries in District Level Training Centres, Electrician-cum-Mechanic, Store Attender, Workshop Attender, Mechanic (Typewriter) Engine Driver and Electrician.

CLASS-B:

Category (1): Librarian

Category (2): Pharmacist Grade-II

Category (3): Dresser.

3. Method of Appointment and appointing authorities:

Subject to the other provisions in these rules, the method of appointment and appointing authority of the several categories of posts shall be as specified in the Table below:-

Deputy Training Officer (ii) If candidates with requisite qualification are not available by direct recruitment.

OR

Where new trades are introduced and no qualified candidates are available with suitable qualifications to hold the post in the new trades then the post shall be filled by direct recruitment.

Category (3) (i) By promotion from category (4) of Class-A Head of the Department
Assistant Training Officer. (ii) If qualified candidates in category-4 are not available

OR

Where new trades are introduced and no qualified candidates are available with suitable qualifications to hold the post in the new trades then the post shall be filled by direct recruitment.

Category (4) By Direct recruitment Deputy Director having Technical Assistant. jurisdiction over the Zones.

CLASS - B

Category (1) Librarian. (i) By direct recruitment, or (ii) Recruitment by transfer from other service. Deputy Director having jurisdiction over the Zones.

Category (2) By Direct recruitment Deputy Director having Pharmacist Grade-II jurisdiction over the Zones.

Category (3) By Direct recruitment Deputy Director having
Dresser jurisdiction over the
Zones.

Note: (a) (i) For the purpose of promotion to the post of Training Officer, Deputy Training Officer only will be considered based on their dates of initial appointment in category (3) for the purposes of reckoning seniority.

(ii) Appointment to the categories of Deputy Training Officer and Assistant Training Officer shall be filled by promotion from the respective feeder categories in each trade or branch concerned.

(b) Seniority shall be fixed from the date of commencement of probation in each trade or branch concerned.

(c) For the purpose of promotion Technical Assistant to Assistant Training Officer and from Assistant Training Officer to Deputy Training Officer separate seniority lists shall be maintained category wise in their respective classes.

(d) For the purpose of promotion from Deputy Training Officer to Training Officer, for every six (6) vacancies the following cycle should be maintained.

- First Vacancy : A Degree/Diploma holder in Engineering/Technology or its equivalent.
- Second vacancy. : A National Apprenticeship Certificate/National Trade Certificate holder in the concerned trade (issued by DGE & T).
- Third vacancy. : A Degree/Diploma holder in Engineer/Technology or its equivalent.
- Fourth vacancy. : A National Apprenticeship Certificate/National Trade Certificate holder in the concerned trade (issued by Director General, Employment & Training).
- Fifth vacancy. : A Degree/Diploma holder in Engineering/Technology or its equivalent.
- Sixth vacancy. : A National Apprenticeship Certificate/National Trade Certificate holder in the concerned trade (issued by Director General, Employment & Training).

In the event of non-availability of a Degree/Diploma holder the vacancy should be filled by National Apprenticeship Certificate/National Trade Certificate holder.

Note: No preference should be given to Degree holders.

4. Reservation of Appointments:

In the matter of direct recruitment preference shall be given to Women to an extent of atleast thirty percent (30%) in the following posts in the Industrial Training Institutes and the District Level Training Centres in each category of open competition, Backward Classes, Scheduled Castes and Scheduled Tribes in terms of rule 22-A of the Andhra Pradesh State Subordinate Service Rules called the "General Rules".

Provided that if sufficient number of Women candidates are not available such vacancies may be filled by Male candidates of the respective categories.

Provided further that in the matter of direct recruitment to any of the posts in Industrial Training Institutes or District Level Training Centres which are exclusively meant for Women, only Women candidates shall be appointed.

5. Reservation for Physically Handicapped Persons:

There shall be reservation for Physically Handicapped Persons for the Class/Categories of posts included in these rules.

6. Qualifications:

(a) No person shall be eligible for appointment to the posts specified in column (2) of the Table annexed to these rules by the method specified in the corresponding column (3) unless he possess the qualifications specified in the corresponding entry in column (4) thereof.

(b) The Commissioner/Director of Employment and Training shall notify from time to time, the specific branch of Degree, Engineering/Diploma in Engineering/Technology or National Apprenticeship Certificate/National Trade Certificate in the relevant Technology or trade, which is relevant for appointment of a candidate as Deputy Training Officer or Assistant Training Officer or Technical Assistant as the case may be in relation to the concerned trade or branch in Industrial Training Institute courses.

7. Age:

No person shall be eligible for appointment by direct recruitment, if he has completed the age of twenty eight (28) years as on 1st day of July of the year in which the Notification for selection is made.

8. Minimum Service:

No person shall be eligible for promotion unless he has put in not less than three years of service in the category from which promotion is to be made.

9. Probation:

(a) Every person appointed to the post by Direct Recruitment shall be on probation for a total period of two years on duty within a continuous period of three years from the date on which he commences probation.

(b) Every person appointed to the post by promotion shall be on probation for a total period of one year on duty within a continuous period of two years from the date on which he commences probation.

10. Training:

All the persons recruited as Assistant Training Officers who are not qualified for Central Training Institute will be sent for Central Training Institute training according to their seniority and availability of seats.

11. Tests:

Every person appointed to the posts in Category 1 under Class-A shall pass Account Test for Subordinate Officers Part-1 during the period of probation.

12. Unit of appointment:

For the purposes of recruitment, appointment, discharge for want of vacancy, re-appointment, seniority, promotion, transfer and posting and appointment as full member to the post specified in column (2) of the Table below, the unit of appointment shall be as specified in column (3) thereof.

13. Transfers and Postings:

The appointing authorities specified in column (3) of the Table under rule 3 shall be competent to effect the transfers and postings of persons for the respective categories.

14. Repeal and Savings:

The Special and Adhoc rules issued from time to time in so far as they relate to the posts included in this service are hereby repealed.

Provided that nothing in these rules shall effect the appointments made to posts for which there were no rules, prior to coming into force of these rules and all such appointments shall be deemed to have been made in accordance with these rules.
