N O T I F I C A T I O N

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of the adhoc rules issued in G.O.Ms.No.767, Education (R) Department, dated, 20.3.979 and as subsequently amended from time to time, the Governor of Andhra Pradesh hereby makes the following Special Rules for the posts existing in the department of Andhra Pradesh, Jawahar Bal Bhavan.

R U L E S

1. Short Title: These rules may be called the Andhra Pradesh Jawahar Bal Bhavan Service Rules.
2. Constitution: The Service shall consist of the following categories of Posts:-

<u>Category</u>	<u>Posts</u>
Category (1)	: Director and Special Officer.
Category (2)	: Assistant Director.

3. Method of Appointment:

The method of appointment for the categories of posts shall be as follows:-

<u>Category</u>	<u>Methods of appointment</u>
1. Director and Special Officer.	(1) By transfer on tenure basis of an officer of the rank of a Deputy Director in the School Education Department or in the women's Development Child welfare Department.

Or

by appointment on contract basis the person having the qualifications specified in

<u>Category</u>	<u>Method of appointment</u>
2. ASSISTANT DIRECTOR:	(i) By appointment by transfer of Superintendent in the Andhra Pradesh Ministerial Service in the Jawahar Bal Bhavan. (ii) If no qualified or suitable Superintendent in the Andhra Pradesh Ministerial Service in Jawahar Bal Bhavan is available, by transfer on tenure basis of and Assistant Director or School Education Department or Assistant Director of the Women's Development and Child Welfare Department or Assistant Director, Information and Public Relations.

4. QUALIFICATIONS : CATEGORY (1) DIRECTOR & SPECIAL OFFICER:

1. No person shall be eligible for appointment by director recruitment to the post of Director and Special Officer unless he possess:-

- (a) A Bachelor's degree in any subject and a Bachelor's degree in Education from a University in India established or incorporated by or under Central Act, or a State Act or Provincial Act or any other equivalent qualification, recognised by the University Grants Commission.
- (b) A Diploma in Fine Arts or Music from a recognised or reputed Institution or must have experience in creative arts particularly those relevant to Children in the age group of 5 - 15 years and
- (c) Must have two years administrative experience in a related Institution.

2. No person shall be eligible for appointment to any post in this service, by any method unless he has studied Telugu as a medium of instruction or as a subject upto Matriculation or its equivalent qualification, preference shall be given to those who have studied Urdu or Hindi also, during their academic career.

Category (2) : Assistant Director:

No person shall be eligible for appointment by transfer to the post of Assistant Director unless the possess the following qualifications, namely :-

- (a) Must be in possession of a Bachelor's Degree or equivalent qualification from a recognised University.
- (b) Preference shall given to those persons having a Degree in Bachelor of Education; and
- (c) Must have passed Accounts Test for Subordinate Officers Part-I and II or the Accounts Test for Executive Officers.

5. Age:

No person shall be eligible for appointment to the post by direct recruitment if he has completed the age of 23 years on the first day of July of the year in which the notification for selection is made.

C. Minimum Service

No person shall be eligible for appointment by transfer to the post of Assistant Director unless he has put in not less than three years of Service in the category of Superintendents in Andhra Pradesh Ministerial Service from which appointment by transfer is made.

7. Probation:

- (a) Every person appointed by direct recruitment, shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.
- (b) Every person appointed by transfer to the post shall from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

8. Tests:

Every person appointed to the post by direct recruitment shall pass the Accounts test for Executive officers, within the period of probation.
