ANDHRA PRADESH SAINIK WELFARE SERVICE RULES**RULES****1. Short Title :**

These rules shall be called the Andhra Pradesh Sainik Welfare Service Rules, 1991.

2. Constitution :

The Service shall consist of the following categories of posts, namely :-

- ✓ Category - 1: Director.
- ✓ Category - 2: Assistant Director.
- ✓ Category - 3: Zilla Sainik Welfare Officer and Placement Officer.
- ✓ Category - 4: Assistant Accounts Officer.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and in supersession of the Adhoc Rules issued in G.O.Ms No. 824, Labour, Employment and Technical Education Department, dated the 25th July, 1977, the Governor of Andhra Pradesh hereby makes the following Special Rules for the Andhra Pradesh Sainik Welfare Service :

3. Method of appointment :

Subject to the provisions contained in these Rules, the method of appointment for the categories of posts mentioned in Rule-2 shall be as follows :-

3. Zilla Sainik Welfare Officer and Placement Officer. (i) By direct recruitment.
(ii) By appointment by transfer of Superintendent in the Andhra Pradesh Ministerial Service in the Sainik Welfare Department.
4. Assistant Accounts Officer. (i) By appointment by transfer of Superintendent in the Andhra Pradesh Ministerial Service in the Sainik Welfare Department.

Note: 66½ of the number of substantive vacancies in the category of Zilla Sainik Welfare Officer and Placement Officer shall be filled by the director recruitment and the remaining by transfer of Office Superintendents in the Andhra Pradesh Ministerial Services in the Sainik Welfare Department.

4. Qualification :

(a) The post of Director and Zilla Sainik Welfare Officer including Placement Officer to be filled up by direct recruitment shall be exclusively filled by Ex-servicemen from the Army, Navy and Air Force.

(b) No Ex-servicemen who retired below the rank of Colonel or equivalent rank in the Army, Navy or Air Force shall be eligible for appointment by direct recruitment as Director.

(c) No Ex-servicemen who retired below the rank of Captain or equivalent rank in the Army, Navy and Air Force shall be eligible for appointment by direct recruitment as Zilla Sainik Welfare Officer and Placement Officer.

(d) No person for appointment to the post of Director, Assistant Director, Zilla Sainik Welfare Officer and Assistant Accounts Officer either by direct recruitment or by promotion shall be eligible unless he possess the minimum general educational qualification prescribed in the schedule to the General Rules or equivalent qualification of Indian Army, Navy or Air Force.

5. Age :

No person who has completed 52 years of age on the first day of July of the year in which the notification for selection is made, shall be eligible for direct recruitment to the post of Director or Zilla Sainik Welfare Officer and Placement Officer.

6. Minimum Service :

No person shall be eligible for appointment by transfer/promotion unless he has put in not less than three years of service in the category from which appointment by transfer/promotion is made.

7. Probation :

(a) Every person appointed by direct recruitment to a post shall, from the date on which he joins duty, be on probation for a period of two years on duty within a continuous period of three years.

(b) Every person appointed to a post by transfer/promotion shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

8. Tests :

(a) Every person appointed to the post of Zilla Sainik Welfare Officer and Placement Officer by direct recruitment shall pass Accounts Test for Subordinate Officers Part-I & II or Executive Officers Test within the period of probation.

(b) No Zilla Sainik Welfare Officer, Placement Officer and Assistant Accounts Officer shall be eligible for promotion to the post of Assistant Director unless he has passed the Executive Officers Test or Accounts Test for Subordinate Officers Part-I and II.

(c) The Superintendent in the Andhra Pradesh Ministerial Service in the Sainik Welfare Department who is promoted as Zilla Sainik Welfare Officer or Placement Officer shall pass the Executive Officers Test or Accounts Test for Subordinate Officers Part-I & II, within the prescribed period of probation.

Provided that if he/she does not pass the test within the total period of two years from the date of promotion, his/her increment on the time scale of pay shall be stopped till he/she passes the test. Such stoppage of increment shall not have the effect of postponing future increment.

ORDER:-

In the G.O.2nd read above, the Government have issued adhoc rules conferring status of appointing authorities in respect of first level gazetted post in the State Service to the Regional Authorities where Regional Officer exist. The Head of the Department shall be the appointing authority for all second level gazetted categories and also initial gazetted categories where no regional officer exists. In respect of the posts in the 3rd level gazetted categories the Government shall be the appointing authority.

2) In the reference 3rd read above, the Government have issued instructions requesting the Department of Secretariat and Heads of Department to make suitable amendments to the existing service rules in this regard.

3) In the reference 4th read above, the Director, Sainik Welfare, Hyderabad has requested the Government to issue necessary amendments to the Andhra Pradesh Sainik Welfare Service Rules, 1991 as there are no Regional Officers exists in the Sainik Welfare Department in respect of the appointment of first level Gazetted categories of the posts of Zilla Sainik Welfare Officer and Placement Officer and also second level Gazetted category of Assistant Director in the Sainik Welfare Department.

4) The Government have carefully examined the proposal of the Director of the Sainik Welfare and have decided to make the Director of Sainik Welfare, Hyderabad as appointing authority in respect of the posts of the first and second level gazetted categories in the Sainik Welfare Department and the Government shall be the appointing authority in respect of the appointment of the Director in the Sainik Welfare Department. Accordingly, the Government have decided to amend the Andhra Pradesh Sainik Welfare Service Rules, 1991 suitably. Therefore, the following notification will be published in the Andhra Pradesh Gazette:-



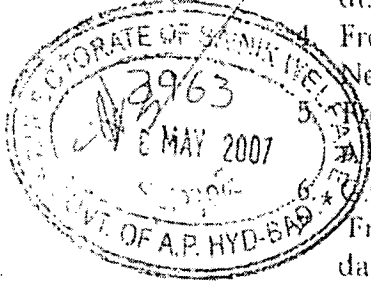

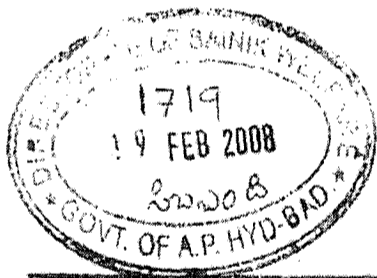
