ORDER:

The Health, Medical and Family Welfare Department have stated that in the letter 3rd read above, the Chief Executive Officer, Aarogyasri Health Care Trust, A.P., Hyderabad has requested the Government for creation and sanction of 706 Technical, Non-Technical posts w.e.f. 01.04.2007 to the Aarogyasri Health Care Trust under Aarogyasri – I and Aarogyasri – II. He has also furnished the resolutions adopted in this regard from time to time by the Board of Trustees chaired by Hon'ble C.M.

2. Further stated that the CEO, Aarogyasri Health Care Trust, Hyderabad has reported that for the implementation of Aarogyasri-I & II Schemes, Aarogyasri Health Care Trust in its various Board meetings held from time to time approved appointment of 706 officers and staff. All the staff appointed are either on deputation or on contract or on outsourcing basis. All the proposed staff requirements were made specially for catering to the 24 hour work cycle of the trust from time to time. The CEO has also requested to ratify the action of the trust to sanction special consolidated pay given the nature of the work. Expenditure on the staff for Aarogyasri – I scheme is being met from the Plan budget of Medical & Health Department under (SH 09) Aarogyasri Health Care Trust under the relevant Head of Account (2008-09) and the expenditure on staff for Aarogyasri-II and CMCO schemes is being met from the CM's Relief Fund in accordance with the orders issued in GOs 1st and 2nd read above respectively. Annual expenditure on the staff for which sanction is now sought is estimated to be Rs. 10.16 crores.

3. The CEO, Aarogyasri Health Care Trust has reported that since Aarogyasri-I & II schemes were implemented under time bound programme and expanded to the whole state in a very short time, advance approval of the Government for the appointment of the staff could not be obtained and the appointments were made by the Trust in the interest of scheme implementation. He has therefore requested the Government to accord sanction for creation of 706 posts and ratify the action taken by the Trust in making the appointment pursuant to the Board resolutions. The Technical staff have to be filled up by drafting the experts on deputation /contract basis; the Non-Technical posts have to be filled up either by drafting the personnel on deputation or drafting the experts from retired personnel/other personnel on contract basis with remuneration fixed by the Board of Trustees. Outsourcing staff have to be appointed as per G.O.Rt.No. 2501, Finance (SMPC) Department, dated. 31.07.2006 and may be paid allowances as fixed by the Board of Trustees. Those outsourcing posts which are not mentioned in the G.O. shall be paid remuneration as fixed by the Board of Trustees. Special allowance is being paid for deputed staff up to the level of Deputy Executive Officer with the concurrence of Finance Department. The other allowances which have been approved by Board of Trustees were also sought for ratification.
