The following Notification will be published in the Andhra Pradesh Extraordinary Gazette dated the 27th October, 2010.

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following Special Rules for Dr.Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh Service.

RULES

1. Short title and commencement:-

- (1) These rules may be called Dr.Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh Service Rules,2010
- (2) They shall be deemed to have come into force on 1st September, 1981.

2. Constitution:-

The service shall consist of the following categories of posts, namely:-

I. Class A:

- Category (1) ... Professor
- Category (2) ... Senior Faculty
- Category (3) ... Faculty

3. Method of Appointment and Appointing Authority

Subject to the provisions of these rules, for the class and category of posts specified in column (1) of the table below, the method of appointment and the appointing authority shall be as specified in the corresponding entries in columns (2) and (3) respectively, thereof:-

4. Tenure :

Appointment on tenure basis to any post in this service shall ordinarily be for a period of three years in the first instance, subject to a maximum period of five years.

Provided that, nothing in these rules shall preclude the Government or the Director General, Dr. Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh, Hyderabad, as the case may be, from repatriating the officers taken on the tenure basis to their parent departments, before expiry of their period of tenure, if it is considered necessary to do so.

5. Qualification :

No person shall be eligible for appointment to the categories specified in Column (1) of the annexure to these rules by the method specified in column (2), unless he/she possesses the qualifications specified in the corresponding entry in column (3) thereof.

Provided that, if an officer working in Dr. Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh, Hyderabad, on tenure basis comes up for promotion during his/her tenure, he/she shall be considered for promotion to the next higher category in Dr. Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh, Hyderabad during his/her tenure period.

6. Reservation of Appointment :

The rule of special representation, as provided in rules 22 and 22 (A) of the Andhra Pradesh State and Sub-ordinate Service Rules, shall apply to appointments by direct recruitment to the various posts in this service provided that no reservation shall be made for physically handicapped persons.

7. Age :

No person shall be eligible for appointment by direct recruitment; if he/she has completed 34 years of age on the first day of July of the year on which the notification for selection is made.

8. Minimum Service :

No person shall be eligible for appointment by transfer or promotion unless he/she is an approved probationer and has put in not less than three (3) years of service in the category from which promotion or appointment by transfer is made.

9. Probation:

- (a) Every person appointed by direct recruitment to any of the posts in this service shall from the date on which he joins duty, be on probation for a total period of two years, on duty, within a continuous period of three years.
- (b) Every person appointed to any of the posts either by promotion or by transfer shall, from the date on which he joins duty be on probation for a total period of one year, on duty, within a continuous period of two years.

10. Tests :

Every person appointed by direct recruitment shall pass the Accounts Tests for Sub-ordinate Officers Part I and II within the period of probation.

11. Savings :

Nothing contained in the Annexure to these Rules, shall adversely affect a person holding a post as on the date of issue of these Rules in the matter of regulating their services.
