Sub: Dr. YSR AHCT – Ops – Modification of Time Limitations and validations in the online process of Dr. YSR Aarogya Sri scheme Preauth and Claim Cases – Online Deployment with effect from 01st July 2020 – Intimation to all the Network Hospitals – Reg.

It is to inform that there are Prescribed Time Limitations and Validations in the online process flow of approval for both Preauth and Claim cases as per the Service Level agreement in the MOU / SCA for better monitoring and quality control of the Schemes.

In this regard the Trust has decided to modify and reduce the existing Time Limitations and Validations to hasten the process of clearance of cases and early release of claim payments to the Network Hospitals.

The recommended Time Limitations and Validations are herewith enclosed in Annexure along with the existing guidelines and description for the notice of the Network Hospitals and will be deployed in the online process of all schemes under Dr. YSR AHCT and same will come into force from 01st July 2020 onwards.

The Network Hospitals are allowed to appeal the Disciplinary Committee for the claims rejected by the Trust ~~except for~~ the following reasons for settlement.

- a) Procedure done before Trust approval of Preauth.
- b) Non submission of Case sheet / submission of wrong case sheet even after the request by the Trust.
- c) Approved procedures not being done as per Preauth approval / On table change of procedure without Telephonic ID.

Hence, all the Network Hospitals are hereby requested to note the modified Time Limitations and Validations carefully, in order to avoid Auto cancellation and act accordingly while updating the Preauthorization and Claim Cases of all schemes under Dr. YSR AHCT within the prescribed time period.

Further, all the District Coordinators are hereby intimated to hold orientation meetings to both Network Hospitals and Aarogya Mitras immediately.
