Sub: Dr. NTRVST-P&C-Free medical facilities to the residents of the Amaravathi Capital City who are residing as on 08.12.2014 – Implementation of Free health facilities – Certain guidelines to Network hospitals - Issued.

Ref: 1. G.O.Ms. No. 52 Health Medical and Family Welfare(I.1) Dept.dated: 12.05.2016.
2. G.O.Ms. No. 127 Health Medical and Family Welfare(I.1) Dept.dated: 27.09.2014 .

It is to inform that Govt. vide reference cited has issued orders, among others that the residents within the Amaravathi Capital City Area who are residing as on 08.12.2014 shall be provided free medical facilities subject to the following conditions and that the Scheme shall be implemented by Dr. NTR Vidya Seva Trust and requested the Chief Executive Officer, Dr. NTR Vidya Seva Trust and the Commissioner, Municipal Administration and Urban Development Authority, Amaravathi for taking necessary action in the matter.

1. They should possess Ration card (White /Pink) and /**Amaravathi resident card** shall be the eligibility.
2. Coverage under the above scheme shall be for the period of 10 years from the Date of implementation.
3. Financial coverage, benefit coverage, claims and appeals, implementation process and other components of free medical treatment shall be applicable as per the Dr. NTR Vaidya Seva Scheme norms / guidelines.


It is also to inform that all the Network hospitals are aware that they have entered into a Service Contract Agreement for providing services to the beneficiaries covered under the existing Schemes as stated therein and any other Scheme is being entrusted by the Government to the Trust from time to time.

The Trust has therefore decided to implement the **Amaravathi Residents Health Scheme** through the Network hospitals along with the ongoing Schemes being implemented by the Trust and issued the following guidelines for their strict compliance.

- i. Online module has been designed for Patient Registration and request for Preauthorization and deployed in the portal of www.ntrvaidyaseva.ap.gov.in.
- ii. The eligible and needy residents of Amaravathi Capital City will approach Network hospital with Ration card (White /Pink) or Amaravathi resident card issued by the Commissioner, Municipal Administration and Urban Development Authority, Amaravathi for availing the quality and cashless treatment under the Amaravathi Residents Health Scheme for the identified 1044 procedures under 29 categories and Follow up treatment for 138 identified listed therapies with the financial coverage of Rs.2.50 Lakhs per family per annum, claims and appeals, implementation process and other components of free medical treatment as is applicable as per the Dr. NTR Vaidya Seva Scheme norms / guidelines.
- iii. 90% of the Amaravathi City families are the White card holders and also beneficiaries under Dr. NTR Vaidya Seva Scheme and the minimum card shall be in inactive status till the implementation of Amaravathi Residents Health policy.
- iv. The case details will be available in continuation of the Dr NTR Vaidya Seva Scheme cases with the claim number “ARHSXXXX” for the Amaravathi Residents Health Scheme.
- v. The past history of the patient of the Amaravathi card holder, if any will be available under Dr. NTR Vaidya Seva Scheme.

All the Network hospitals are therefore requested to follow the above guidelines and provide the quality and cashless treatment to the need eligible beneficiaries covered under the Amaravathi Residents Health Scheme. as 90% of the families are Dr.NTR Vaidya Seva beneficiaries already covered under the Scheme.
