The Following Notification will be published in the A.P. Gazette.

NOTIFICATION

The Government at Andhra Pradesh here by approve the following Adhoc Rules for the Temporary Posts in the District Bal Bhavan and Bal Kendras.

The Rules hereby made shall be deemed to have come into force with effect from 12th March-1980.

RULES

01. These Rules may be called the Bal Bhavans and Bal Kendras Service Rules.
02. The temporary posts in the Bal Bhavans and Bal Kendras shall consists of the following categories, namely.

Category: 01. Superintendent
02. Art Instructor, Vocal Music, Instrumental Instructor, Dance Instructor,
and Tailoring.
03. Attender cum Chowkidar
04. Sweeper cum-Ayah

03. Appointment: Appointment to the posts mentioned in Rule 2 shall be made by the methods specified in the corresponding entries in column (3) there of the Annexure.

04. Appoinmtng Authority :

(a) The Dist.Collector shall be the appointing authority in respect of all the posts mentioned in Rule 2 with the following as members:

His / Her nominee presence in the Selection Committee meeting will be Compulsory.

(b) For Direct recruitment candidates should be called through employment exchange & through paper notification in two (2) local papers, one of which should be in Telugu News paper. Candidates applying in response to news papers advertisement shall both be called for the interview. Candidates applying in response to news papers advertisement, should have registered their names in the Employment Exchange.

(c) QUALIFICATIONS : No person shall be eligible for appointment to any post in columns (2) of the annexure by the method specified in the columns (3) unless he posses the qualifications specified in the corresponding entry in col. (4) thereof.

06. AGE: No person shall be eligible for appointment by direct recruitment unless he / she completes 25 years of age in respect of the posts of superintendent and 18 years in respect of other posts.
07. PROBATION: Every person appointed by direct recruitment shall on probation for a total period of two years on duty with in a continuous period of three years and every person appointed by transfer or promotion shall be on promotion for a total period of one year on duty within a continuous period of two years.
08. UNIT OF APPOINTMENT: (a) For the purpose of direct recruitment promotion and appointment by transfer discharge, Re-appointment etc., District shall be the unit.
(b) For inter District transfer of the employees working in Bal Bhavans / Bal Kendras in the state permission of the Director & Special Officer, Jawahar Bal Bhavan shall be compulsory.
09. LEAVE RULES: In respect of Casual Leave, Earned Leave, Half Pay Leave and other kind of leave, the Leave rules as applicable to state Government employees such as FRs and AP leave Rules-1933 from time to time, shall be followed in respect of employees of Bal Bhavans only. Where as in respect of part time employees of Bal Kendras only casual leave and optional holidays can be availed.
10. SUPERANNUATION : An employee shall retire from Service of Bal Bhavans / Bal Kendras
i) On his / her attaining the age of 58 years, or the age applicable to state Government employees from time to time.
OR
ii) On his/her being declared medically unfit for Service by the Medical Officer or Medical Board as directed by the Government from time to time.
iii) On imposition of the penalty of compulsory retirement.
11. In case where no specific mention is made regarding any aspect, the rules and regulations as applicable to the state Government employees shall apply in the Bal Bhavans / Bal Kendras also.
12. SAVINGS: Nothing contained in these rules shall adversely affect any person who is in service in Bal Bhavans / Bal Kendras on the date of commencement into force of these rules.
13. POWER TO RELAX RULES: The Government shall relax any of the provisions in these rules involving any undue hardship to any employee of Bal Bhavans / Bal Kendras or in Public interest.

03.	Attender-cum-Chowkidar in Bal Bhavan / Bal Kendras	i) Director Recruitment. (OR) ii) Appointment by transfer from the person working in the same posts in Bal Kendra in the Concerned District units.	i) Must have passed VI Class. ii) Must be able to ride Bicycle.
04.	Sweeper -cum Ayah -in Bal Bhavan / Bal Kendras.	i) Director Recruitment. (OR) ii) Appointment by transfer from the person working in the same post in Bal Bhavan / Bal Kendras in the concerned District unit.	i) Must be able to read & Write Telugu and Urdu or English and Hindi.
