The following notification will be published in the A.P.Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and all other powers hereunto enabling and in supersession of Special Rules issued in G.O.Ms No. 1113, General Administration (Rules) dated 07-09-1961 read with G.O.Ms No. 44, Education Department, dated 20-01-1973 and G.O.Ms. No.77, General Administration (CA.II) Department, dated 19-02-1985 and any subsequent modifications, amendments if any in so far as they relate to the posts included in this service and also supersession of Adhoc Rules issued in G.O. Ms. No. 913, Education (D) Department, dated 18-11-1982 and in G.O.Ms.No 283, Education Department dated 06-02-1985, the Governor of Andhra Pradesh hereby makes the following Special Rules for Andhra Pradesh State Cultural Affairs Subordinate Services:-

Rules

1. SHORT TITLE: These rules may be called "The Andhra Pradesh Cultural Affairs Subordinate Service Rules".
2. CONSTITUTION: This service shall consist of the following categories of posts in the A.P.State Cultural Affairs Subordinate Services:
Category (1) - Lecturer, Government College of Music & Dance

Subject to the other provision in these rules, the method of appointment and appointing authority for the several categories shall be as follows:-

Category	Method of Appointment	Appointing Authority

1. Lecturer in Government College of Music And Dance	Appointment by promotion from the category of Assistant Lecturers of Music and Dance and Gayak Assistants.	Director of Culture.
Assistant Lecturer.	I) By Direct Recruitment. II) By promotion from the category of Accompanists.	Director of Culture
3. Accompanists including Gayak Assistants.	By Direct Recruitment.	Director of Culture
4. Programme Assistant.	By Direct Recruitment	Director of Culture

NOTE:1 In the matter of appointment by transfer of Assistant Lecturers and Gayak Assistants as Lecturers the following shall be the order:-

- 1st Vacancy: By appointment by transfer from the category of Assistant Lecturers
2nd Vacancy: By appointment by transfer from the category of Assistant Lecturers
3rd Vacancy: By appointment by transfer from the category of Gayak Assistants

The above cycle shall be followed till the Gayak Assitants as on date of issue of these rules, get promoted or vacate the posts due to retirement or for any other reasons.

NOTE-2 For purpose of appointment to the posts of Lecturers in each branch of Music, the Assistant Lecturers of the respective branch only shall be considered. Gayak Assistants will be considered for the posts of Lecturers in Vocal Music Only.

NOTE -3 For purpose of promotion as Accompanists in each branch of Music

Rule 2 refers to the Gayak Assistant to be appointed as Accompanists after the issue of these rules.

NOTE - 4 For direct recruitment to any category covered by these rules selection of candidates shall be made by a Committee constituted by the Director of Culture.

4. RESERVATION OF APPOINTMENT: In the matter of direct recruitment to the posts for which women and men are equally suited, there shall be reservation to Women to an extent of 33 1/3% of the posts in each category of O.C., B.C - A, B.C - B, B.C - C, B.C - D, S.C., S.T., Physically Handicapped and Ex- Servicemen Quota.

5. QUALIFICATIONS: No person shall be eligible for appointment to the category specified in column (1) of the Annexure by the method specified in the corresponding entry in column (2) unless he possesses the qualification specified in the corresponding entry in column (3) thereof :-

NOTE: The proficiency or capability of a person will be assessed by the Committee constituted by the Director of Culture.

6. AGE: No person shall be eligible for appointment by direct recruitment, if he has completed the age of 35 years on the first day of July of the year in which the vacancy is notified for selection.

7. MINIMUM SERVICE: No person shall be eligible for promotion unless he has put in ordinarily three years of service but in a case shall it be less than two years in the category, class or grade from which promotion or transfer is made.

8. PROBATION: (a) Every person appointed by Direct Recruitment to the posts of Assistant Lecturers, Accompanists and programme Assistants shall from the date on which he commences probation be on probation for a total period of two years on duty within a continuous period of three years.

(b) Every person appointed to any of the posts by promotion shall, from the date on which he

seniority, appointment as full member and discharge for want of vacancy, the unit of appointment for the posts in the services shall as specified in the table below:-
