ORDER:-

The following notification will be published in the Andhra Pradesh Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and all other powers hereunto enabling and in supersession of the rules issued earlier in G.O.Ms.No.458, Education Department, dated the 2nd May, 1979 and G.O.Ms.No.64, Education Department, dated the 17th February, 1988, the Governor of Andhra Pradesh hereby makes, the following Special Rules for the Andhra Pradesh Oriental Manuscripts Library and Research Institute Service:-

RULES

1. SHORT TITLE

These rules may be called the Andhra Pradesh Oriental Manuscripts Library and Research Institute Service Rules, 1999.

2. CONSTITUTION:-

The service shall consist of the following categories of posts, namely:-

Category (1) : Director

Category (2) : Deputy Director (Research)

Category (3) : Assistant Director (Administration)
(Previously Designated as Administrative Officer)

3. METHOD OF APPOINTMENT AND APPOINTING AUTHORITY:-

Subject to the other provisions of these rules, the method of appointment and the Appointing Authority to the categories shall be as follows:-

(1) Director	<p>(i) By Transfer of the Principal of a Government Degree College or an Officer of an equivalent rank from any Government Department or Faculty member not below the rank of a Reader.</p> <p align="center">OR</p> <p>on tenure basis of an Officer not below the rank of a Principal of Government Degree College or an Officer of an equivalent rank from any Government Department or Faculty member not below the rank of the Reader.</p> <p>(ii) By promotion from the category of Deputy Director (Research) or Assistant Director (Administration).</p> <p>(iii) If no qualified and suitable candidate is available for appointment by methods (i) and (ii) above, by direct recruitment or by appointment on contract basis.</p> <p><u>NOTE:</u> Appointment by contract basis shall not exceed for a period of three years at a time.</p>	Government
(2) Deputy Director (Research)	<p>(i) By transfer from the category of Research Officer in the languages of Telugu or Sanskrit or Urdu or Arabic or Persian in the Andhra Pradesh Oriental Manuscripts Library and Research Institute.</p> <p align="center">OR</p> <p>by transfer from any other class or service holding a post identical to that of Research Officers in the Andhra Pradesh Oriental Manuscripts Library and Research Institute.</p> <p>(ii) If no qualified and suitable candidate is available for appointment by the method (i) above, by direct recruitment.</p>	Director
(3) Assistant Director (Administration)	<p>(i) By transfer from the category of Superintendents of the Andhra Pradesh Oriental Manuscripts Library and Research Institute.</p> <p>(ii) If no qualified and suitable Superintendent is available for appointment by method (i) above, the post shall be filled up by transfer of an Officer of an equal rank from any other Government Department.</p>	Director

4. AGE:-

No person shall be eligible for appointment to any post in the service by direct recruitment if he has completed the age of 50 years on the first day of July of the year in which the notification for selection is made.

5. QUALIFICATIONS:-

No person shall be eligible for appointment to the categories specified in column (1) of the Annexure appended to these rules by the method specified in column (2), unless he possess the qualifications specified in the corresponding entry in column (3) thereof.

6. TESTS:-

No person shall be eligible for appointment by transfer or by promotion to any of the posts in the service unless he has passed the Accounts Test for Executive Officers or the Accounts Test for Subordinate Officers Part-I and Part-II. Those who were appointed by direct recruitment should pass these tests during the period of probation. The person appointed on contract basis need not pass these tests.

7. MINIMUM SERVICE:-

No person shall be eligible for appointment by transfer or by promotion unless he has put in not less than three (3) years of service in the category from which the appointment by transfer or promotion is made.

8. PROBATION:-

- (a) Every person appointed by direct recruitment to any post shall, from the date on which he commences his probation be on probation for a period of two years within a continuous period of three years.
- (b) Every person appointed to any post either by promotion or by transfer (not by transfer on tenure basis) shall, from the date on which he commences his probation be on probation for a period of one year on duty within a continuous period of two years.

(iii)by direct recruitment or on contract basis	(i)Must possess a Doctorate degree in Sanskrit or Persian or Telugu with adequate knowledge of Sanskrit or Persian or Telugu as the case may be, other than the language in which Doctorate degree has been obtained from any University in India established or incorporated or Provincial Act or State Act or an Institution recognised by the University Grants Commission or an equivalent qualification and also should have studied History at Bachelor level. (ii)Must have atleast five (5) years experience in independent Research in Sanskrit or Persian or Telugu literature after obtaining a Doctorate Degree or an equivalent qualification and (iii)Adequate knowledge in editing of palm-leaf manuscripts in Sanskrit or Persian or Telugu as the case may be.
Deputy Director (Research)	(i)By transfer from category of Research Officer in the languages of Telugu, Sanskrit or Urdu or Arabic or Persian (ii)By Transfer from any other Class or Service OR (iii)by direct recruitment	Must have put in three years of service in the category of Research Officer in the languages of Telugu or Sanskrit or Urdu or Arabic or Persian in the Oriental Manuscripts Library and Research Institute. (i)Must possess M.A. in Telugu or Sanskrit or Urdu or Arabic or Persian Literature with not less than 50% of marks from any University in India established or incorporated by or a Central Act or Provincial Act or State Act or an Institution recognised by the University Grants Commission or an equivalent qualification and should have studied History at Bachelor level. (ii)Must possess research experience in Telugu or Sanskrit or Urdu or Persian equivalent to that of Research Officer in the Oriental Manuscripts Library and Research Institute for a period not less than five years.
(3)Assistant Director (Administration)	Appointment by transfer	(i)Must possess a Bachelor's Degree in any subject from any University in India established or incorporated by or under a Central Act or State Act or an Institution recognised by the University Grants Commission or an equivalent qualification. A Certificate in Library Science. (ii)Must have put in atleast 3 years of regular service in the category of Superintendent.
