The following notification shall be published in the Andhra Pradesh Gazette:--

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of the Adhoc rules issued in G.O.Ms.No.99, Education, dated the 16th February, 1984, the Governor of Andhra Pradesh hereby makes the following Special Rules for the Andhra Pradesh Registration of Publications Service:--

R U L E S

1. Short title:--

These rules may be called the "Andhra Pradesh Registration of Publications Service Rules".

2. Constitution:--

The service shall consist of the following categories of posts in the Andhra Pradesh Registration of Publications Service:--

Category: (1) -- Registrar of Publications

Category: (2) -- Assistant Registrar of Publications.

3. Method of appointment:--

Appointment to the following categories shall be made as follows:--

(1) Registrar of Publications	The Director of Public Libraries will be Ex-officio Registrar of Publications.
(2) Asst.Registrar of Publications.	(1) By appointment by transfer from the category of Reader, Grade-I of the Office of the Registrar of Publications.

(ii) By direct recruitment if no suitable and qualified person is available by method (i).

4. Minimum Service:

No person shall be eligible for appointment by transfer unless he has put in not less than three years of service in the category from which the transfer is made.

5. Qualifications:

No person shall be eligible for appointment to the post of Assistant Registrar of Publications unless he possesses the qualifications specified in the Column (3) against each of the method of appointment specified in column (2) of the Annexure to these rules.

6. Probation:-

Every person appointed to the post of Assistant Registrar of Publications shall, from the date on which he joins duty be on probation for a total period of one year on duty within a continuous period of two years, if recruited by transfer and if recruited by direct shall be on probation for a total period of two years on duty within a continuous period of three years.

7. Tests:-

Every person appointed to the post of Assistant Registrar of Publications by direct recruitment shall pass the Accounts Test for Executive Officers or Accounts Test for Subordinate Officers, Part-I & II within the period of probation.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following Adhoc rules for the temporary post of Deputy Registrar of Publications (2<sup>nd</sup> level Gazetted) in the office of the Registrar of Publications, Andhra Pradesh, Hyderabad.

**RULES**

**1 SHORT TITLE:**

These rules may be called the Andhra Pradesh Registrar of Publications Service Rules, 2012.

**2 CONSTITUTION:**

The post of Deputy Registrar of Publications is a distinct class in the Andhra Pradesh Registrar of Publications Service Rules in the office of the Registrar of Publications.

**3 METHOD OF APPOINTMENT AND APPOINTING AUTHORITY:**

Subject to the other provisions in these rules, the method of appointment to the category of Deputy Registrar of Publications and appointing authority shall be as follows:

Method of Appointment (1)	Appointing Authority (2)
<p><u>1</u> By promotion from the category of Asst. Registrar of Publications of the Registrar of Publications or</p> <p><u>2</u> By direct recruitment if no suitable and qualified candidate is available by method (1)</p>	Government

4. QUALIFICATIONS:

No person shall be eligible for appointment to the category as specified in column (1) of the Annexure to these rules by the method specified in the corresponding entry in column (2) thereof, unless he / she possesses the qualifications specified in the corresponding entry in column (3) thereof. However, two years time from the date of issue of this order may be allowed, for passing the Department tests.

5. MINIMUM SERVICE:

No member of the service shall be eligible for promotion to the category of Deputy Registrar of Publications unless he is an approved probationer and has put in not less than three years continuous service in the category from which such promotion is made.

6. PROBATION:

Every person appointed to the category of Deputy Registrar of Publication from the date on which he joins duty, be on probation for a period two years on duty within a continuous period of three years.,if he is a direct recruit and every person appointed by promotion to the post shall, from the date on which he / she commences probation, be on probation for a period one year on duty within a continuous period of two years.
