

The attention of all the Medical Superintendents of Empanelled Government Institutions of AP Vaidya Vidhana Parishad and Director of Medical Education is invited to the reference 3rd cited where in guidelines on operation of Revolving Fund under Dr. NTR Vaidya Seva Trust have been issued and following modifications to the above said guidelines are issued.

1. Inclusion of Biomedical Engineer from APMSIDC in the administrative sanction approval committee at state level in addition to the existing members as mentioned at Sl. No. 4 under Heading of Proposals from the Indenting and Sanctioning Mechanism.
2. The Hospital purchase committee authorized for purchase of equipment and also for execution under Heading of Purchase Mechanism and Execution Mechanism in the earlier guidelines dated : 27.07.2016 have been cancelled with immediate effect and after the administrative sanction approval is given by Administrative Sanction Committee it will be sent to the APMSIDC for procurement.
3. The State level committee will meet every first Friday of the Month at 03:00 PM at DME Office at Vijayawada and submit proposals to APMSIDC for further procurement.
4. The Medical Superintendent of Hospital will send proposal to Director of Medical Education / Commissioner of APVVP under intimation to CEO, Dr. NTR VST.

It is further informed that in the minutes of the meeting of Revolving Fund administrative committee held by CEO, Dr. NTR VST on 25.10.2016 which was communicated vide reference 4th cited, it was decided that APMSIDC may not be involved in the procurement of equipment under revolving fund. However, in view of the modifications suggested to the earlier guidelines dated: 27.07.2016 as detailed above all the Superintendents of Government Institutions are requested to procure the equipment through APMSIDC only.
