The provisions, clauses, stipulations, covenants contained in this Appendix – I are applicable upon the Dr.YSR Arogaysri scheme(Aarogyasri), Ayushman Bharat –Pradhan Mantri Jan Arogya Yojana(AB PMJAY), Employees Health Scheme(EHS), Working Journalist Health Scheme(WJHS), Amaravathi Residents Health Scheme(ARHS), Arogya Raksha Scheme(ARS), Amrutha Health Scheme for Orphans and Destitute and any other scheme(s) entrusted by the Government to the Trust ,as the case may be in its relevant contexts

Whereas Dr.YSR Aarogyasri Health Care Trust has been registered as a Trust of Government of Andhra Pradesh, vide document no.164/2019 at the office of SRO, Guntur for implementation of all its schemes under the Trust to provide cashless health care services to the beneficiaries for the identified surgeries/therapeutic procedures as per respective guidelines of the Trust in the empanelled hospitals in 26 districts of State of Andhra Pradesh and other states.

The First party, inspected the hospital of the second party and agreed to let the second party to provide the services based on the General Conditions as mentioned in Appendix- I

Whereas second party has expressed his/her desire to join as network hospital and has represented that their hospital has requisite facilities to serve to the beneficiaries as covered under schemes of the Trust agreeing on terms and conditions as in Appendix-I.

The second party has to pay a stipulated fee as detailed in the table given below, as mentioned in Circular vide Lr.No.Dr.YSR AHCT/EMP/ /2020 Dated 09.0.2020

This MoU shall become effective after it has been duly approved and signed by both the parties and shall not be amended except in writing by both the parties.
