3. The Vendor should supply all IT assets to the O/o Dr. YSR Aarogyasri Health Care Trust, MGM Capital Building, Mangalagiri, Guntur with their own expenses.
4. The vendor should provide all the IT assets in a good working condition.
5. The 100% payment will be made to the vendor after delivery of all the Assets with a good working condition and duly verified & Certified by the Trust Officials.
6. Penalty of 0.5% of the total bid amount per day will be levied in case of delay after the stipulated time was completed subject to a maximum penalty of 10% of the total invoice amount.
7. The Trust reserves the right to accept or reject the tender without assigning any reason and the contract of any or all the lots may be allotted by the Trust to one or more than one tenderer as the Trust may deem fit and no claim/complaint in this regard will be entertained by Stockholder.
8. The Trust reserves the right to withdraw the tender in full or part thereof prior to or after the acceptance of the tender without assigning any reason whatsoever.
