Sub:- Dr.NTR Vaidya Seva- Empanelment- Constitution of **Dr. Nandamuri Taraka Rama Rao Vaidya Seva Trust** by the Govt. of the State of Andhra Pradesh and renaming of scheme as **Dr.Nandamuri Taraka Rama Rao Vaidya Seva (Dr.NTRVS) - Intimation - Reg.**

It is to inform that, the erstwhile Government of composite State of Andhra Pradesh launched a community health insurance scheme called "Rajiv Aarogyasri Health Insurance Scheme" with effect from 01.04.2007 with the objective of providing quality health care to the poor for identified diseases through Network Service providers from the Government and private sector.

On consequent Reorganization of the State of Andhra Pradesh into the states of Telangana and Andhra Pradesh with effect from 02.06.2014, the Government of State of Andhra Pradesh vide reference 1<sup>st</sup> cited issued orders for renaming the Rajiv Aarogyasri scheme as Dr.Nandamuri Taraka Rama Rao Aarogya Seva Scheme with addition of 100 procedures to the existing procedures and enhanced the existing limit of financial coverage from Rs. 2.00 lakhs to Rs.2.50 lakhs per family per annum in order to provide the cashless treatment to the poor in the empanelled network hospitals. The Government of Andhra Pradesh renamed Dr.Nandamuri Taraka Rama Rao Aarogya Seva Scheme as "Dr.Nandamuri Taraka Rama Rao Vaidya Seva" by virtue of amendment orders issued vide G.O.Ms.No. 157, Health Medical & Family Welfare(I.1)Department, Dated.17.12.2014.

Further it is to inform that, subsequent to reorganization of Andhra Pradesh into the States of Andhra Pradesh and Telangana, as per orders of the Govt. of Andhra Pradesh vide G.O.Ms.No.404, Health & Medical & Family Welfare (II) Department, dated 05.08.2015 a Trust is constituted in the name of "Dr.Nandamuri Taraka Rama Rao Vaidya Seva Trust, Govt. of Andhra Pradesh" in order to effectively govern, manage, administer and facilitate the implementation of the Dr.NTR Vaidya Seva and other schemes under the Trust.

In view of the above context, it is hereby brought to the notice of all the Network Hospitals located in both States i.e. State of Andhra Pradesh and State Telangana empanelled with Aarogyasri Health Care Trust that treatment shall be provided to the beneficiaries belonging to the State of Andhra Pradesh for 1044 procedures with a financial coverage of Rs.2.50 lakhs per family per annum under "Dr.NTR Vaidya Seva Scheme" as per the guidelines already prevailing.

The network hospitals located in both the States shall also provide services to the beneficiaries, in accordance with the guidelines pertaining to the respective Schemes as applicable to the beneficiaries of the State of Andhra Pradesh i.e. Employees Health Scheme, Working Journalist Health Scheme, CMCO etc.

All the Network hospitals located in State of Andhra Pradesh and Telangana are requested to follow the instructions and guidelines issued from time to time under Dr.NTR Vaidya Seva Trust, which will form part of the Service Contract Agreement (SCA) by virtue of Article 2(6) (b)" Circulars/GOs of SCA in SCC executed by the empanelled network hospitals with the United State of Aarogyasri Health Care Trust.

Further the network hospitals are informed that the "New Service Contract Agreement under Dr.Nandamuri Taraka Rama Rao Vaidya Seva Trust" will be deployed as early as possible in the portal with instructions to register and to furnish to the Trust as per the Circulars/guidelines issued.

The above instructions shall be followed scrupulously by all the empanelled network hospitals, located in both the States of Andhra Pradesh and Telangana, and shall continue to provide quality care services without interruption strictly adhering to the existing guidelines as well as those that may be issued from time to time.
